## ORDINANCE NO. **A** – <u>37</u> 2

## AN ORDINANCE ATTACHING AND INCORPORATING CERTAIN RECENTLY ANNEXED LANDS TO WARDS OF THE CITY OF CONWAY; DECLARING AN EMERGENCY; AND FOR OTHER PURPOSES

WHEREAS, the Circuit Court of Faulkner County, Arkansas, did, on the 24th day of July, 1961, enter its order annexing certain lands to the City of Conway, Arkansas; and

WHEREAS, no appeal has been taken from said order, the time for filing appeals therefrom has expiped, and said order has become final; and

WHEREAS, the City desires to attach and incorporate said lands to the respective wards of said City:

NOW, THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF CONWAY, ARKANSAS :

SECTION ONE (1). The following lands are hereby attached to and incorporated within Ward One (1) of said City, to-wit:

All that part of the Southwest Quarter (SW1) of the Southwest Quarter (SW1), Section Seven (7), Township Five (5) Narth, Range Thirteen (13) West, lying West of the centerline of U, S. Highway No. 65 as the same is now situated;

A part of the West One-half  $(W_{\pm})$  of the Northwest Quarter  $(NW_{\pm})$  of Section Eighteen (18), Township Five (5) North, Range Thirteen (13) West, more particularly described as follows: Beginning at a point Fifteen and Seventy-five Hundredths (15.75) chains Narth of the Southwest Corner of said West One-half  $(W_{\pm})$  of the North-West Quarter  $(NW_{\pm})$  and rum thence North Eighty (80) degrees East to the center of U. S. Highway 10. 65; thence Northwesterly along the center of said Highway to the North line of said West One-half  $(W_{\pm})$  of the North line of said West One-half  $(W_{\pm})$  of the Northwest Quarter  $(NW_{\pm})$ ; thence West to the Northwest corner of said West One-Half  $(W_{\pm})$  of the Northwest Quarter  $(NW_{\pm})$ ; thence, South to the point of beginning;

Also the following lands situated in Township Five (5) North, Range Fourteen (14) West:

The Southeast Quarter  $(SE_{\pm})$  of the Northeast Quarter  $(NE_{\pm})$ , and the South Two Hundred (200) feet of the Northeast Quarter  $(NE_{\pm})$  of the Northeast Quarter  $(NE_{\pm})$ , all in Section Fourteen (14);

The Northwest Quarter  $(NW_{\pm})$  of the Southeast Quarter  $(SE_{\pm})$ , and the West One-half  $(W_{\pm})$  of the Southwest Quarter  $(SW_{\pm})$  of the Northeast Quarter  $(NE_{\pm})$  of Section Eleven (11).

It is the intent of this ordinance that, following such attachment and incorporation of the above lands to said Ward One (1)of said City, said Ward One (1)shall be comprised of all lands situated within the following boundaries, to-wit:

Beginning in the center of the intersection of Main Street with Chestnut Street in said City and run thence Southeasterly along the center of Chestnut Street to the point where it intersects the center of U. The following lands are hereby attached to

The South One-half  $(S\frac{1}{2})$  of the Southwest Quarter  $(SW\frac{1}{4})$  of Section Five (5), Township Five (5) North, Range Thirteen (13) West, and the South One-Half  $(S\frac{1}{2})$  of the Southeast Quarter  $(SE\frac{1}{4})$  of Section Six (6), Township Five (5) North, Range Thirteen (13) West.

It is the intent of this Ordinance that, following such attachment and incorporation of the above lands to said Ward Two (2), said Ward Two (2) shall be comprised of all lands situated within the following boundaries, to-wit:
