OHDINANCE NO. A- 402

AN ORDINANCE ACCEPTING THE ANNEXATION OF CERTAIN LANDS TO THE CITY OF CONWAY, ARKANSAS: ASSIGNING AND INCOR-PORATION SUCH LANDS TO A WARD IN SAID CITY: DECLARING AN EMERGENCY; AND FOR OTHER PURPOSES

WHEREAS, the County Court of Faulkner County, Arkansas did, on the 6th day of May, 1963, enter its order annexing certain lands to the City of Conway, Arkansas; and

WHEREAS, no appeal has been taken from said order, the time for filing appeals therefrom has expired, and said order has become final; and

WHEREAS the City of Conway desires to accept such annexation and to attach and incorporate said lands to the proper ward of said City:

NOW, THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF CONWAY, ARKANSAS:

SECTION 1. The City of Conway, Arkansas hereby accepts the hereinafter described property, annexed to said City by order of the County Court of Faulkner County, Arkansas, heretofore entered on May 6th, 1963, said territory being situated in Faulkner County, Arkansas and described as follows, to-wit:

All that part of the South One-Half $(S^{\frac{1}{2}})$ of the Northeast Quarter $(NE^{\frac{1}{4}})$ of the Northeast Quarter $(NE^{\frac{1}{4}})$ of Section Two (2), Township Five (5) North, Range Fourteen (14) West, containing Eleven (11)acres, more or less, and lying North and East of the right-of-way of the Missouri Pacific Railroad, except the following portion thereof, to-wit: Begin at a point Twenty (20) feet South of the Southeast corner of the North One-Half $(N^{\frac{1}{2}})$ of the Northeast Quarter $(NE^{\frac{1}{4}})$ of the Southeast Quarter $(SE^{\frac{1}{4}})$ of said Section Two (2), and run thence North Twenty (20) feet; thence West One Hundred Twenty (120) feet; thence in a Southeasterly direction to the point of beginning.

and that said above described **lands** and terfitory be, and the same hereby are, declared to be a part of the City of Conway, Faulkner County, Arkansas.

SECTION 2. From and after this date the inhabitants residing within and upon the hereinabove described lan s and territory shall have and enjoy all the rights and privileges of, and be subject to all the laws, rules, ordinances, limitations and regulations imposed upon the inhabitants within the original limits of said City.
