AN ORDINANCE ACCEPTING THE ANNEXATION OF CERTAIN TERRITORY TO THE CITY OF CONWAY, ARKANSAS: DECLARING SUCH TERRITORY TO BE A PART OF SAID CITY: DECLARING AV EMERGENCY: AND FOR OTHER PURPOSES.

WHEREAS, certain property owners lying adjacent to the City limits of Conway, Arkansas, did petition the County Court of Faulkner County, Arkansas for an order annexing the hereinafter described territory to said City; and

WHEREAS, after proceedings being had upon notice by publication, all as provided by and in accordance with the laws of the State of Arkansas, the Judge of the County Court of Faulkner County, Arkansas, did, on Aug. 2, 1971, enter his order of annexation to said City of the hereinafter described lands:

NOW, THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF CONWAY, ARKANSAS:

SECTION 1. That the City Council of Conway, Arkansas does hereby accept the hereinafter described territory, annexed to said City by order of the County Court of Faulkner County, Arkansas, heretofore entered on Aug. 2, 1971, said territory being described as follows, to-wit:

Beginning at the Southeast corner of the Northeast Quarter (NE 1/4) of the Southwest Quarter (SW 1/4) of Section Three (3), Township Five (5) North, Range Fourteen (14) West, which is in the center of a County Road, and run thence West Twenty-five (25) feet; thence run South Eighty-eight (88) degrees 00 minutes West a distance of Three Hundred Fifty (350) feet; thence South Eighty-six (86) degrees Fifty (50) minutes West a distance of One Hundred Sixty (160) feet; thence South Eighty-seven (87) degrees Fifty (50) minutes West a distance of One Hundred Sixty (160) feet; thence South Eighty-seven (87) degrees Fifty (50) minutes West a distance of Eighty (80) feet; thence South Eighty-eight (88) degrees Ten (10) minutes West a distance of Eighty (80) feet; thence South Eighty (80) degrees Ten (10) minutes West a distance of One Hundred Sixty (160) feet; thence South Eighty-five (85) degrees Fifteen (15) minutes West a distance of Three Hundred Nine (309) feet and to the Southwest corner of said Northeast Quarter (NE 1/4) of the Southwest Quarter (NE 1/4); thence North Three (3) degrees 00 minutes West along and with the West line of said Northeast Quarter (NE 1/4) of the Southwest Quarter (NE 1/4) and to the Northwest corner thereof; thence East along and with the North line of said Northeast Quarter (NE 1/4) of the Southwest Quarter (NE 1/4) and to the Northwest Quarter (NE 1/4) and to the Northeast corner thereof; thence South along and with the East line of said Northeast Quarter (NE 1/4) of the Southwest corner thereof; thence South along and with the East line of said Northeast Quarter (NE 1/4) of the Southwest Quarter (SW 1/4) to the point of beginning; Ordinance No. A-____

And that said above described lands and territory be, and the same hereby are, declared to be a part of the City of Conway, Faulkner County, Arkansas.

SECTION 2. It is ascertained and declared that it is necessary for the protection and preservation of the public health and safety that the foregoing ordinance be passed and adopted; that an emergency exists; that this ordinance shall take effect and be in force from and after its passage and publication.
