

ORDINANCE NO. A- 574

AN ORDINANCE ACCEPTING THE ANNEXATION OF CERTAIN TERRITORY TO THE CITY OF CONWAY, ARKANSAS; DECLARING SUCH TERRITORY TO BE A PART OF SAID CITY; DECLARING AN EMERGENCY; AND FOR OTHER PURPOSES.

WHEREAS, certain property owners lying adjacent to the City limits of Conway, Arkansas, did petition the County Court of Faulkner County, Arkansas, for an order annexing the hereinafter described territory to said City; and

WHEREAS, after proceedings being had upon notice by publication, all as provided by and in accordance with the laws of the State of Arkansas, the Judge of the County Court of Faulkner County, Arkansas, did, on September 26, 1973, enter his order of annexation to said City of the hereinafter described lands:

NOW, THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF CONWAY, ARKANSAS:

SECTION 1: That the City Council of Conway, Arkansas, does hereby accept the hereinafter described territory, annexed to said City by order of the County Court of Faulkner County, Arkansas, heretofore entered on September 26, 1973, said territory being described as follows:

A part of the Northeast Quarter Southeast Quarter (NE $\frac{1}{4}$ SE $\frac{1}{4}$) more particularly described as follows: Beginning at a point 669.00 feet West of the Northeast corner of said NE $\frac{1}{4}$ SE $\frac{1}{4}$ and run thence South 522.7 feet; thence West 321 feet; thence North 522.7 feet; thence East 321 feet to the point of beginning; also beginning at a point 1,042.5 feet West of the Northeast corner of said NE $\frac{1}{4}$ SE $\frac{1}{4}$ and run thence South 522.7 feet; thence West 247.5 feet; thence North 522.7 feet; thence East 247.5 feet to the point of beginning; all being a part of and contained in Section 14, township 5 North, Range 14 West, containing 6.84 acres, more or less, as surveyed and platted by Rufus Haydon, County Surveyor.

And that said above described lands and territory be, and the same hereby are, declared to be a part of the City of Conway, Faulkner County, Arkansas.

SECTION 2: It is ascertained and declared that it is necessary for the protection and preservation of the public health and safety that the foregoing ordinance be passed and

adopted; that an emergency exists; that this ordinance shall take effect and be in force from and after its passage and publication
