## ORDINANCE NO. 0-92-18

AN ORDINANCE AMENDING SECTIONS 201.1 AND 201.3 OF THE CONWAY LAND DEVELOPMENT CODE; DECLARING AN EMERGENCY AND FOR OTHER PURPOSES:

NOW, THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF CONWAY, ARKANSAS:

SECTION 1: That the Zoning District Boundary Map of the Conway Land Development Code be amended by changing all the C-2 and C-3 symbols and indications as shown on the 'Zoning District Boundary Map in an area described as follows:

Description. A part of the NE 1/4 of the SW 1/4 of Section 36, T6N, R14W more particularly described as follows: Beginning at a point 770 feet East and 153 feet North 22° West of the southwest corner of said NE 1/4, SW 1/4 of said Section 36 and running thence East 260 feet; thence North 22° West along the west side of Washington Avenue 130 feet; thence West 260 feet; thence South 22° East 130 feet to the point of beginning.

to those of MF-3, and a corresponding use district is hereby established in the area above described and said property is hereby rezoned.

SECTION 2: That all ordinances in conflict herewith are repealed to the extent of the conflict.

SECTION 3: That this ordinance is necessary for the protection of the public peace, health and safety and an emergency is hereby declared to exist, and this ordinance shall be in full force and effect from and after its passage and approval.
