## IN THE MATTER OF THE ABANDONMENT OF AN EASEMENT

WHEREAS, the owners of Outlot 2 of the Wal-Mart Subdivision in Conway have asked that a blanket utility easement, dedicated to the City of Conway, across said Outlot 2 be abandoned. Said utility easement across Outlot 2 is a part of an easement recorded in Deed Record Book No. 500, Page 184 in the Faulkner County Circuit Clerk's Office at the Faulkner County Courthouse.

WHEREAS, the City of Conway Planning Commission has approved a Roplat of the said Outlot 2 which dedicates specific utility easements to serve Outlot 2 which will become effective upon the recording of the Replat.

NOW, THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF CONWAY, ARKANSAS:

SECTION ONE: The City of Conway, Arkansas, hereby releases, vacates and abandons all its rights, together with the right6 of the public generally, in and to the blanket easement above described insofar as its applies to Outlot 2 of the Wal-Mart Subdivision to the City of Conway, Arkansas.

SECTION TWO: A copy of this ordinance, duly certified by the City Clerk, shall be filed in the Office of the Recorder of the County and recorded in Deed Records of the County.

SECTION THREE: It being necessary for the protection and preservation of the public health, safety, and welfare, an emergency is hereby declared to exist and this Ordinance shall

take effect from and after its passage and publication and the recordation of the Replat of Outlot 2 of the Wal-Mart Subdivision to the City of Conway, Arkansas.
