ORDINANCE NO. 0-92-50

AN ORDINANCE AMENDING THE ZONING ORDINANCE OF THE CONWAY LAND DE-VELOPMENT CODE TO ALLOW A COUNTRY CLUB AS A CONDITIONAL USE IN R-1 ONE FAMILY RESIDENTIAL DISTRICTS; DECLARING AN EMERGENCY; AND FOR

THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF NOW, CONWAY, ARKANSAS:

Section 1: That the Addendum to Zoning Ordinance, which lists the Table of Permitted Uses, is hereby amended to allow the use of a "Country club, golf course, swimming pool, or other private recreational uses usually associated with a social country club or subdivision association operated for mutual recreation of members and not for a profit" as a conditional use in an R-1 One Family Residential District.

Section 2: That all ordinances in conflict herewith are repealed to the extent of the conflict.

Section 3: That this ordinance is necessary for the protection of the public peace, health and safety, and an emergency is hereby declared to exist, and this ordinance shall be in full force and effect from and after its passage and approval.
