

ORDINANCE NO. 0-92-55

AN ORDINANCE ABANDONING AN EASEMENT: DECLARING AN EMERGENCY; AND FOR OTHER PURPOSES:

WHEREAS, a petition was duly filed by adjoining property owner asking the City Council to abandon an alley hereinafter described; and

WHEREAS, a Resolution was adopted by the City Council calling for public hearing to be held on November 24, 1992 and further said Resolution directed the Clerk to prepare the necessary notice; and

WHEREAS, the hereinafter described alley has not been used by the City or by the public generally or by any other persons and that to abandon said alley would not interfere or cause any hardship upon the general public or the City of Conway.

NOW, THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF CONWAY, ARKANSAS:

SECTION 1. That the following described alley be and the same is hereby abandoned and vacated by the City of Conway, Arkansas, to-wit:


An alley separating Lots 1 and 4 from 2 and 3 of Block 40, of Robinson Plan running from Prince Street to Cross Street in Conway, Arkansas.

SECTION 2. That all ordinances in conflict herewith are repealed to the extent of the conflict.

SECTION 3. That this ordinance is necessary for the protection of the public peace, health and safety and an emergency is hereby declared to exist, and this ordinance shall be in full force and effect from and after its passage and approval.
