

AN ORDINANCE ACCEIPTING THE ANNEXATION OF CERTAIN LANDS TO THE CITY OF CONWAY, ARKANSAS; DECLARING AN EMERGENCY; AND FOR OTHER PURPOSES:

NOW, THEREFORE, $^{\mathbf{B}}_{\mathbf{E}}$ it ordained by the city council of the city of conway, arkansas:

Section 1: The City of Conway, Arkansas, hereby accepts the hereinafter described territory, annexed to said City by order of the County Clerk of Faulkner County, Arkansas, heretofore entered on the 29th day of August, 1995, and said territory being situated in Faulkner County, Arkansas, shall be a part of said City of Conway and shall be zoned Agricultural and described as follows:

Part of the SE 1/4 SW 1/4, Section 15 and part of the North 1/2 NW 1/4, Section 22, all in Township 5 North, Range 14 West, Faullkner County, Arkansas, more particularly described as follows: beginning at the Southeast corner of said North 1/2 NW 1/4; thence West 2,640.1 feet more or less to the Southwest corner of said North 1/2 NW 1/4; thence North along the West line of said North 1/2 NW 1/4, 225.0 feet; thence East, 220.4 feet; thence North 416.7 feet to the center line of Donnell Ridge Road; thence Northeastwardly along the center line of Donnell Ridge Road; thence Northeastwardly along the center line of Donnell Ridge Road; thence Northeastwardly along the center line of Donnell Ridge Road; Section 15; thence or less to a point 454.7 feet West and 400.0 feet North of the Southeast corner of said SE 1/4 SW 1/4, Section 15; thence South 400.0 feet; thence East, 454.7 feet to the Southeast corner of said SE 1/4 SW 1/4, Section 15, thence South, 1,320.0 feet more or less to the point of beginning. Containing 67 acres, more or less.

and that said above-described lands and territory be, and the same hereby are, declared to be a part of the City of Conway, Faulkner County, Arkansas.

Section 2: From and after this date, the inhabitants residing within and upon the hereinabove described lands and territory shall have and enjoy all the rights and privileges of, and be subject to all the laws, rules, ordinances, limitations and regulations imposed upon the inhabitants within the original limits of said

City of Conway, Arkansas, and for voting purposes, said lands are hereby assigned to and designated as a part of Ward One (1) of the City of Conway, Arkansas.

Section 3: It is hereby ascertained and declared that it is necessary for the protection and preservation of the public health and safety that the foregoing ordinance be passed and adopted; that an emergency exists; and that this ordinance shall take effect and be in force from and after its passage and publication.
