ORDINANCE NO. 0-96-26

AN ORDINANCE AMENDING SECTIONS 201.1 AND 201.3 OF THE CONWAY LAND DEVELOPMENT CODE; DECLARING AN EMERGENCY AND FOR OTHER PURPOSES:

NOW, THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF CONWAY, ARKANSAS:

SECTION 1: That the zoning District Boundary Map of the Conway Land Development Code be amended by changing all the $\underline{A-1}$ symbols and indications as shown on the Zoning District Boundary Map in an area described as follows:

TRACT # 3 (MF2): Being a part of the W1/2, NE1/4 of Section 4, T-5-N, R-14-W Faulkner County, Arkansas more particularly described as beginning at the SW corner of said W1/2, NE1/4, thence N-0-13-1.8-W along the West line of said W1/2, NE1/4 40.0 feet, thence N-89-35-49-E parallel to the South line of said W1/2, NE1/4 40.0 feet, thence N-0-13-18-W 375.0 feet to the point of beginning, thence continue N-0-13-18-W 870.0 feet, thence N-89-35-49-E 610.49 feet to the East.line of the W1/2, W1/2, NE1/4 Section 4, thence S-0-23-07-E along said East line 870.0 feet, thence S-89-35-49-W 6112.98 feet to the point of beginning containing 12.22 acres, more or less.

TRACT # 5 (R-1): Being a part of the W1/2, NE1/4 of Section 4, T-5-N, R-14-W Faulkner County, Arkansas more particularly described as beginning at the SW corner of said W1/2, NE1/4, thence N-0-13-18-W along the West line of said W1/2, NE1/4 40.0 feet, thence N-89-35-49-E parallel to the South line of said W1/2, NE1/4 40.0 feet, thence N-0-13-18-W 1820.0 feet to the point of beginning, thence continue N-0-13-18-W 797.83 feet to the North line of said W1/2, NE1/4; said point being 40.0 feet S-89-57-13-E of the NW corner of said W1/2, NE1/4; thence along the North line of said W1/2, NE1/4 S-89-57-13-E 606.58 feet to the NE corner of the W1/2, W1/2, NE1/4, thence S-0-23-07-E along the East line of said W1/2, W1/2, NE1/4 793.05 feet, thence S-89-35-49-W 608.85 feet to the point of beginning containing 11.10 acres, more or less.
