AN ORDINANCE AMENDING SECTIONS 201.1 AND 201.3 OF THE CONWAY LAND DEVELOPMENT CODE; DECLARING AN EMERGENCY AND FOR OTHER PURPOSES:

NOW, THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF CONWAY, ARKANSAS:

SECTION 1: That the Zoning District Boundary Map of the Conway Land Development Code be amended by changing all the <u>A-1</u> symbols and indications as shown on the Zoning District Boundary Map in an area described as follows:

Being a part of the E ½ SE ¼ of Section 34, and also a part of the W ½ SW ¼ of Section 35 all in T-6-N R-14-W Faulkner County, Arkansas described as beginning at the SW corner of said E ½ SE ¼ Section 34; thence S-89-16-54-E 1171.73 feet to the point or beginning; thence N-33-09-16-W 502.66 feet; thence N-56-50-44-E 125.0 feet; thence N-16-50-43-E 102.20 feet; thence N-0-01-13-E 281.05 feet; thence N-63-00-50-W 50.98 feet; theince N-52-13-44-W 43.32 feet; thence S-63-53-45-W 44.89 feet; thence N-89-58-47-W 50.0 feet; thence S-0-01-13-W 4.92 feet; thence N-89-58-47-W 120.0 feet; thence N-0-01-13-E 35.76 feet; thence N-52-13-44 W 273.02 feet; thence N-89-58-47-W 124.96 feet; thence N-0-01-13-E 557.11 feet to the South right of way of the Missouri Pacific Railroad; thence along said right of way to a point S-39-24-37-E 80.36 feet; thence to a point along a 2079.50 feet radius S-52-30-15-E 942.21 feet; thence to a point N-24-24-07-E **50.0**feet; thence to a point S-65-35-53-E 329.96 feet to a point in Salem Road; thence leaving said right of way **of** a railroad S-01-27-30-E 933.33 feet to the NE corner of Section 3 T-5-N R-14-W; thence N-88-53-44-W 222.39 feet to the SE corner of the E ½ SE ¼ Section 34; thence N-89-16-54-W 150.03 feet to the point of beginning containing 17.16 acres more or less.

to those of **R-2**, and **a** corresponding use district **is** hereby established in the area above described and said property is hereby rezoned.
