ORDINANCE NO. O-99- AB

AN ORDINANCE ACCEPTING THE ANNEXATION OF CERTAIN LANDS TO THE CITY OF CONWAY, ARKANSAS; DECLARING AN EMERGENCY; AND FOR OTHER PURPOSES:

NOW, THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF CONWAY, ARKANSAS:

SECTION 1: The City of Conway, Arkansas hereby accepts the hereinafter described territory, annexed to said City by order of the County Court of Faulkner County, Arkansas., heretofore entered on the 30TH day of APRIL, 1999, and said territory being situated in Faulkner County, Arkansas shall be a part of the City of Conway and shall be zoned A-1 and described as follows:

Part of the SW 1/4 of Section 36, Township 5 North, Range 14 West, Faulkner County, Arkansas, described as beginning at the Northwest corner of said SW 1/4 S-89-32-43-E 46.60 feet; thence parallel to the West line of said SW 1/4 S-0-25-W 466.70 feet; thence S-89-32-43-E 420.0 feet; thence S-0-25-W 1529.24 feet; thence S-89-24-40-W 466.67 feet to the West line of said SW 1/4; said point being 624.0 feet N-0-25-E of the SW corner of said SW 1/4; thence N-0-25-E 2004.44 feet to the point of beginning.

and that said above-described land and territory be, and the same hereby are, declared to be a part of the City of Conway, Faulkner County, Arkansas.

SECTION 2: From and after this date, the inhabitants residing within and upon the hereinabove described lands and territory shall have and enjoy all the rights and privileges of, and be subject to all the laws, rules, ordinances, limitations and regulations imposed upon the inhabitants within the original limits of said City of Conway, Arkansas, and for voting purposes, said lands are hereby assigned to and designated as part of Ward 4 of the City of Conway, Arkansas.

SECTION 3: It is hereby ascertained and declared that it is necessary for the protection and preservation of the public health and safety that the foregoing ordinance be passed and adopted; that an emergency exists; and that this ordinance shall take effect and be in force from and after its passage and publication.
