## ORDINANCE NO. 0-00-76

AN ORDINANCE AMENDING SECTIONS 201.1 AND 201.3 OF THE CONWAY LAND DEVELOPMENT CODE; DECLARING AN EMERGENCY AND FOR OTHER **PURPOSES:** 

## NOW, THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF CONWAY, ARKANSAS:

SECTION I = That the Zoning District Boundary Map of the Conway Land Development Code be amended by changing all the A-1 symbols and indications as shown on the Zoning District Boundary Map in an area described as follows:

Being a part of the SW 114 NW 114, Section 5 T-5-N, R-14-W, Faulkner County, Arkansas, described as beginning at a point 25.0 feet S-00-10-23-E from the NE comer of said SW 114 NW 114, thence S-00-10-23-E along the east line of said SW 114 NW 114 930.20 feet; thence leaving said east line N-68-51-24-W 161.09 feet; thence S-00-10-23-E 26.84 feet; thence S-68-51-24-E 161.09 feet to the east line of the SW 114 NW 114; thence along said east line S-00-10-23-E341.72 feet to the SE corner of said SW 114 NW 114; thence S-89-18-13-W along the south line of said SW 114 NW 114 1326.16 feet to the SW corner of said SW 114 NW 114; thence along the west line of said SW 114 NW 114 N-00-10-55-W 1318.26 feet to the NW comer of said SW 114 NW 114; thence along the north line N-89-03-58-E 30.00 feet. Thence leaving the north line S-00-10-55-E 777.29 feet; thence S-83-49-46-E 955.59 feet; thence north 53.18 feet; thence S-68-51-24-E 157.03 feet; thence N-00-10-23-W 26.84 feet; thence N-68-51-24-W 156.95 feet; thence N-67-15-15-W 706.64 feet; thence north 425.0 feet; thence east 60.00 feet; thence S-77-53-06-E 497.03 feet; thence east 214.20 feet; thence N-00-08-16-W 198.40 feet; thence N-89-03-58-E 235.90 feet to the point of beginning containing 28.65 acres more or less.
