ORDINANCE NO. 0 - 02 - 6

AN ORDINANCE ACCEPTING THE ANNEXATION OF CERTAIN LANDS TO THE CITY OF CONWAY, ARKANSAS; DECLARING AN EMERGENCY; AND FOR OTHER PURPOSES:

NOW, THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF CONWAY, ARKANSAS:

Section 1: That the City of Conway, Arkansas, hereby accepts the hereinafter described territory, annexed to said City by order of the County Court of Faulkner County, Arkansas, heretofore entered on the 5 h day of March 2002 and said territory being situated in Faulkner County, Arkansas, shall be a part of the City of Conway and shall be zoned <u>A-1</u> and described as follows:

Part of the **NE** 114 SE 114 Section 19, T-5-N, R-13-W, Faulkner County, Arkansas, described as commencing at the NE corner of said **NE** 1/4 SE 114 Section 19, T-5-N, R-13-W and run thence S-88-55-35-W along the north line of said **NE** 114 SE 1/4 947.0 feet to the point of beginning ; thence S-88-55-35-W 269.71 feet to the east right of way of Missouri-Pacific Railroad; thence S-23-00-E along said right of way 300.35 feet; thence N-75-00-E 245.86 feet to the **west** right of way of State Highway #365; thence N-21-21-00-W along said right of way 233.89 feet to the point of beginning, containing **1.5** 1 acres more or less.


and that above said – described lands and territory be, and the same hereby are, declared to be a part of the City of Conway, Faulkner County, Arkansas.

Section **2**: That the City of Conway hereby accepts the following sections of streets for the sole purpose of providing street frontage for the issuance of building permits, but not for maintenance.

South Harkrider

Section 3: That unless a street is specifically named in this ordinance as being accepted for maintenance or to provide street frontage for the issuance of building permits, it shall not be accepted for either purpose.

Section 4: From and after this date, the inhabitants residing within and upon the hereinabove described lands and territory shall have and enjoy all the rights and privileges of, and be subject to all the laws, rules, ordinances, limitations and regulations imposed upon the inhabitants within the original.limits of said City of Conway, Arkansas, and for voting purposes, said lands are hereby assigned to and designated as a part of Ward 4 of the City of Conway, Arkansas.

Section 5: It is hereby ascertained and declared that it is necessary for the protection and preservation of the public health and safety that the foregoing ordinance shall take effect and be in force from and after its passage and publication.
