## **ORDINANCE NO. 0-02-77**

AN ORDINANCE AMENDING THE CONWAY ZONING ORDINANCE TO REMOVE THE REQUIREMENT FOR SITE PLAN REVIEW BY THE PLANNING COMMISSION AND/OR CITY COUNCIL FOR SEVERAL TYPES OF DEVELOPMENT; DECLARING AN EMERGENCY; AND FOR OTHER PURPOSES:

**WHEREAS**; the Conway Zoning Ordinance currently requires the Planning Commission and/or City Council to review potential site plans for a number of types of developments, and;

**WHEREAS;** there are no established guidelines under which most of these site plans are to be reviewed, and;

WHEREAS; these reviews substantially delay construction for these projects, and;

**WHEREAS**; a site plan review process with guidelines and to be conducted as a staff review is under development;

NOW, THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF CONWAY, ARKANSAS:

DEVELOPMENT CRITERIA, 4. Additional Criteria in C-4 - Large Shopping Center

**Section 2:** That <u>SECTION 401.5 – COMMERCIAL AND OFFICE DISTRICTS</u>, E. <u>DEVELOPMENT CRITERIA</u>, 5. <u>Additional Criteria for 0-1 General Office District</u>, b. of the CONWAY ZONING ORDINANCE as adopted by Ordinance **0-94-54** on September **27**, **1994** is hereby amended to read as follows:

"b. Properties within the District shall be contiguous."

**Section 3:** That <u>SECTION 401.8 – S-1 INSTITUTIONAL DISTRICT</u>, D. <u>DEVELOPMENT CRITERIA</u>, 1. of the CONWAY ZONING ORDINANCE as adopted by Ordinance **0-94-54** on September **27**, **1994** is hereby amended to read as follows: "1. Properties in this District shall be contiguous,"



**Section 5**: That <u>SECTION 601.21 – RELIGIOUS ACTIVITIES</u> of the CONWAY ZONING ORDINANCE as adopted by Ordinance O-94-54 on September 27, 1994 is hereby amended to delete the following requirement:

"B. The site plan must be approved by the Planning Commission."
