NOW, THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF **CONWAY, ARKANSAS:**

SECTION 1: That the Zoning District Boundary Map of the Conway Land Development Code be amended by changing all the R-1 symbols and indications as shown on the Zoning District Boundary Map in an area described as follows:

Being a part of the S1/2 N1/2 NE1/4 NE1/4 Section 23, T-5-N, R-14-W, Faulkner County, Arkansas more particularly described as beginning at the NE corner of said S1/2 N1/2 NE1/4 NE1/4 thence N88°27'46"W 260.97 feet; thence S02°20'28"W 209.93 feet; thence S02°24'52"W 82.42 feet to the point of beginning thence continuing S02°24'52"W 41.08 feet; thence N83°22'46"W 8.18 feet; thence N88°26'49"W 948.16 feet; thence N01°47'05"E 184.31 feet; thence S88°11'59"E 86.39 feet to the point of curvature of a curve left with a radius of 50.00 feet and a chord bearing and distance of S42°20'06"E 67.34 feet; thence S88°26'49"E 685.00 feet to the point of curvature of a curve right with a radius of 25.00 feet and a chord bearing and distance of S68°50'37"E 16.78 feet; thence S49°14'27"E 114.36 feet to the point of curvature of a curve left with a radius of 85.00 feet and a chord bearing and distance of S62°01'31"W 37.62 feet to the point of beginning containing 2.92 acres more or less.
