## ORDINANCE NO. 0-03- 81

ORDINANCE CORRECTING THE LEGAL DESCRIPTION OF THE PROPERTY REZONED FROM A-I & SR TO R-2 BY ORDINANCE NO. O-03-66; DECLARING AN EMERGENCY AND FOR OTHER PURPOSES:
