## AN ORDINANCE CORRECTING THE LEGAL DESCRIPTION OF THE PROPERTY REZONED FROM R-1 TO R-2 BY ORDINANCE NO. 0-03-172; DECLARING AN EMERGENCY AND FOR OTHER PURPOSES:
