### AN ORDINANCE AMENDING SECTIONS 201.1 AND 201.3 OF THE CONWAY ZONING ORDINANCE TO REZONE PROPERTY LOCATED ON THE SOUTH SIDE OF MONROE STREET 50 FEET WEST OF THE INTERSECTION OF MONROE AND FACTORY STREETS FROM R-2A TO C-3:
