ORDINANCE NO. 0-05-74

AN ORDINANCE AMENDING THE CONWAY ZONING ORDINANCE TO ALLOW APARTMENTS IN COMMERCIAL ZONES BY CONDITIONAL USE PERMIT, DECLARING AN EMERGENCY AND FOR OTHER PURPOSES:

Whereas; it is desirable to promote mixed uses of residential and commercial;

**Whereas**; it is also desirable to promote a mixed use environment to encourage a pedestrian friendly community.

NOW, THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF CONWAY, ARKANSAS:

Section 1: That SECTION 401.5 COMMERCIAL AND OFFICE DISTRICTS, C. USE REGULATIONS, 1. PERMITTED USES, 4. RESIDENTIAL USES, of the Conway Zoning Ordinance as adopted by Ordinance No. O-94-54, September 1994 be amended as follows:
