**ORDINANCE NO. 0-06-94**

**AN ORDINANCE APPROPRIATING FUNDS FOR A BRIDGE PORT RESIDENTIAL TRASH TRUCK; DECLARING AN EMERGENCY, AND FOR OTHER PURPOSES,** by \_\_\_\_\_ D.C.

WHEREAS, the City of Conway Sanitation Department has a need for a residential trash truck, which was bid on July 10, 2006 with a low bid accepted from Barloworld in the amount of \$180,621, and which was not previously budgeted,

NOW THEREFORE BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF CONWAY, ARKANSAS, THAT:

SECTION 1. The City of Conway Sanitation Department shall appropriate funding from the Sanitation Enterprise Fund – Fund Balance (50.990) and purchase the 2007 Bridge Port Residential Trash Truck from Barloworld in the amount of \$180,621 (50.118.931).

SECTION 2. All ordinances in conflict herewith are repealed to the extent of the conflict.


