AN ORDINANCE AMENDING SECTIONS 201.1 AND 201.3 OF THE CONWAY ZONING ORDINANCE TO REZONE PROPERTY LOCATED ON THE NORTH SIDE OF PRINCE STREET APPROXIMATELY 0.5 MILES WEST OF THE INTERSECTION OF COUNTRY CLUB ROAD AND PRINCE STREET SURROUNDED BY SHADY VALLEY SUBDIVISION ON THE EAST SIDE, WESTMINISTER SUBDIVISION ON THE NORTH SIDE AND GLENWOOD PLACE PUD FOR A PORTION OF THE WEST SIDE FROM A-1 TO PUD;
