AN ORDINANCE WAIVING COMPETITIVE BIDS FOR POLICE VEHICLES FOR THE CONWAY POLICE DEPARTMENT, DECLARING AN EMERGENCY AND FOR OTHER PURPOSES

WHEREAS, the Conway Police Department desires to purchase twelve (12) police cars for which budgetary authority has been provided in the FY 2010 budget, and;

WHEREAS, Landers Brothers Chrysler Dodge Jeep can provide such vehicles at prices comparable to state contract price and will coordinate installation of specialized law enforcement equipment which may allow the City of Conway to have the vehicles placed in service quicker than other vendors;

NOW, THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF CONWAY, ARKANSAS THAT:

SECTION 1. The City does hereby waive the requirement for obtaining competitive bids and does hereby approve the purchase of twelve (12) patrol cars from Landers Brothers Chrysler Dodge Jeep;

SECTION 2. This ordinance is necessary for the protection of the public peace, health and safety and an emergency is hereby declared to exist, and this ordinance shall be in full force and effect from and after its passage and approval.

SECTION 3: All ordinances in conflict herewith are repealed to the extent of the conflict.

AN ORDINANCE WAIVING BIDS FOR THE PURCHASE OF TWO NEW FIRE TRUCKS FOR THE CONWAY FIRE DEPARTMENT; DECLARING AN EMERGENCY; AND FOR OTHER PURPOSES

WHEREAS, the Conway Fire Department has an immediate need to purchase a new fire truck, which budgetary authority for such purposes has been approved through the FY 2010 budget, and;

NOW, THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF CONWAY, ARKANSAS THAT:

Section 1. The City of Conway shall waive the requirements for obtaining bids for the purchase of two new fire trucks and shall utilize Pro Fire Equipment as a single source vendor;

Section 2. This ordinance is necessary for the protection of the public peace, health and safety, an emergency is hereby declared to exist, and this ordinance shall be in full force and effect from and after its passage and approval.
