City of Conway, Arkansas Ordinance No. <u>0-10-114</u>

AN ORDINANCE AMENDING THE BUILDING PERMIT FEES FOR THE CONSTRUCTION AND ALTERATIONS OF BUILDINGS IN THE CITY OF CONWAY: AMENDING SECTION 11.16.06.A.1.01 OF THE CONWAY MUNICIPAL CODE; AND FOR OTHER PURPOSES.

WHEREAS, The City of Conway would like to update the building permit fees for the construction and alterations of buildings;

NOW THEREFORE BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF CONWAY, ARKANSAS THAT:

SECTION 1. Section 11.16.06.A.1.01 of the Conway Municipal Code be hereby amended to read as follows:
