City of Conway, Arkansas Ordinance No. <u>O-10-43</u>

AN ORDINANCE AMENDING THE MECHANICAL PERMIT FEES FOR THE CONSTRUCTION AND ALTERATIONS OF MECHANICAL SYSTEMS IN BUILDINGS IN THE CITY OF CONWAY: AMENDING SECTION 11.56.05.01 OF THE CONWAY MUNICIPAL CODE: DECLARING AN EMERGENCY AND FOR OTHER PRUPOSES.

WHEREAS, The City of Conway would like to update the mechanical permit fees for the construction and alterations to the mechanical systems installed in buildings;

NOW THEREFORE BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF CONWAY, ARKANSAS THAT:

SECTION 1. Section 11.56.05.01 of the Conway Municipal Code be hereby amended to read as follows:

"11.56.05.01 Mechanical Permit fees.

11.56.06.A.1.01 Schedule of mechanical permit fees. A fee for each mechanical permit shall be paid in accordance with the following schedule:

1.	Heating and Cooling Systems for a new	\$0.06 per square foot of area under roof, with a minimum of
	construction, Additions and Accessory Buildings	\$36.00, whichever is greater.
2.	Remodel, Renovations, Alterations, Replacement and Repairs to:	
	One and Two Family Dwellings	\$30.00
	Other than One and Two Family Dwellings	
	Boilers	\$50.00 for one boiler + \$15.00 per each addn. boiler
	Commercial Vent Hoods and Exhaust Systems	\$50.00 for one exhaust system + \$15.00 per each addn. system
	Ductwork	\$50.00 for one system + \$35.00 per each addn. system
	HVAC Change Out/Repair	\$50.00 for one unit + \$25.00 per each addn. unit
	Refrigeration	\$50.00 for one refrigeration unit + \$15.00 per each addn. uni
4.	Re-Inspections and Additional Inspections (*See note below)	\$25.00 per inspection
5.	Work commencing before permit issuance	Permit fee shall be doubled
6.	Building Code Appeals Board Application Fee	\$250.00

SECTION 2. All ordinances in conflict herewith are repealed to the extent of the conflict.
