AN ORDINANCE TO WAIVE THE COMPETITIVE BID PROCESS FOR THE PURCHASE OF A USED HYDRAULIC EXCAVATOR FOR THE DEPARTMENT OF SANITATION; DECLARING AN EMERGENCY; AND FOR OTHER PURPOSES

Whereas, the City of Conway requires the use of hydraulic excavators in the operations of the City's landfill; and

Whereas, the City of Conway currently has a 2008 Komatsu excavator with 8,232 hours that is in need of replacement; and

Whereas, the City of Conway was able to find a used excavator that would meet the department's needs and have a significant cost savings when compared to used and new equipment; and

Whereas, the City of Conway Department of Sanitation has funds available to cover the cost of this equipment in the previously approved budget.

NOW THEREFORE BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF CONWAY, ARKANSAS THAT:

- **Section 1**. The City of Conway shall waive the competitive bid process and approve the above purchase from Hugg & Hall in the amount of \$177,900.
- Section 2. All ordinances in conflict herewith are repealed to the extent of the conflict.
- Section 3. This ordinance is necessary for the protection of the public peace, health and safety; an emergency is hereby declared to exist, and this ordinance shall be in full force and effect from and after its passage and approval.
