AN ORDINANCE APPROPRIATING FUNDS FOR THE CONWAY FIRE DEPARTMENT; WAIVING BID REQUIREMENTS TO UTILIZE A SOLE SOURCE, DECLARING AN EMERGENCY; AND FOR OTHER PURPOSES:

Whereas, the City of Conway requests approval to place an order with G&W Emergency Vehicle Specialist enter into a financial agreement with PNC Equipment Finance for the purchase of a Pumper/Rescue unit in the amount of \$699,227 after a prepay discount; and

Whereas, the Conway Fire Department requests approval to order said unit based on the terms and conditions in the agreements between the City of Conway, G&W Emergency Vehicle Specialist and PNC Equipment Finance; and

Whereas, the Conway Fire Department requests to appropriate \$260,000 from General Fund Balance Appropriation account to use as a down payment; and

Whereas, the Conway Fire Department will be responsible for 5 yearly payments of \$96,517.90 and will include that amount in budget years 2019-2023.

## NOW THEREFORE BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF CONWAY, ARKANSAS, THAT:

**Section 1.** The City of Conway shall appropriate an amount of \$260,000 from the General Fund Balance Appropriation account (001-119-4900) into the Fire Department Machinery & Equipment account (001-131-5910).

**Section 2.** That after Council approval of this ordinance the City of Conway Fire Department shall place an order with G&W Emergency Vehicle Specialist and submit \$260,000 down payment and shall utilize G&W Emergency Vehicle Specialist as a single source vendor.

**Section 3.** This ordinance is necessary for the protection of the public peace, health and safety, an emergency is hereby declared to exist, and this ordinance shall be in full force and effect from and after its passage and approval.

Section 4. All ordinances in conflict herewith are repealed to the extent of the conflict.
