AN ORDINANCE APPROPRIATING REIMBURSEMENTS FUNDS FROM VARIOUS ENTITIES FOR THE CONWAY POLICE DEPARTMENT; AND FOR OTHER PURPOSES

Whereas, the City of Conway has received reimbursements funds from the following entities:

Various Companies	\$35,378.77	Extra Duty Services
AR State Police	\$6,302.03	Taskforce Funds

Whereas, the Conway Police Department needs these funds to replenish their expenditure account.

NOW, THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF CONWAY, ARKANSAS THAT:

Section 1. The City of Conway shall appropriate funds from various companies in the amount of \$35,378.77 from 001.121.4185 to the CPD overtime expense account, 001.121.5114.

Section 2. The City of Conway shall appropriate funds from ASP in the amount of \$6,302.03 from 304.000.4201 to the CPD expense account 001.121.5114.

Section 3. The City of Conway shall appropriate funds from Paymac, Inc. in the amount of \$1,997.01 from 001.119.4611 to the CPD vehicle maintenance account 001.121.5450.

Section 4. The City of Conway shall appropriate funds from various companies in the amount of \$4,824.67 from 001.119.4360 to the CPD vehicle maintenance account 001.121.5450.

Section 5. The City of Conway shall appropriate funds from various companies in the amount of \$495.23 from 001.119.4900 to the CPD grant and donation account 001.121.5699.

Section 6. The City of Conway shall appropriate funds from various companies in the amount of \$4,270.06 from 001.121.4185 to CPD overtime account 001.121.5114.

Section 7. All ordinances in conflict herewith are repealed to the extent of the conflict.

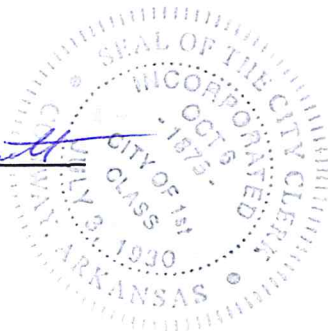
