**Ordinance No. O-22-135**

**AN ORDINANCE APPROPRIATING REIMBURSEMENTS FUNDS FROM VARIOUS ENTITIES FOR THE CITY OF CONWAY POLICE DEPARTMENT; AND FOR OTHER PURPOSES**

**Whereas**, the City of Conway has received reimbursements funds from the following entities:

Various Companies	\$34,882.07	Extra Duty Services
DEA/Marshall	\$5,377.09	Taskforce Funds
Municipal Vehicle Program	\$10,034.67	Insurance Proceeds
Municipal Vehicle Program	\$674.83	Insurance Proceeds

**Whereas**, the Conway Police Department needs these funds to replenish its expenditure accounts.

**NOW, THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF CONWAY, ARKANSAS THAT:**

**Section 1.** The City of Conway shall appropriate funds from various companies in the amount of \$34,882.07 from 001.121.4185 to the CPD overtime expense account, 001.121.5114.

**Section 2.** The City of Conway shall appropriate funds from various companies in the amount of \$5,377.09 from 001.121.4185 to the CPD overtime account 001.121.5114.

**Section 3.** The City of Conway shall appropriate funds from Municipal Vehicle Program in the amount of \$10,034.67 from 001.119.4360 to the CPD vehicle maintenance expense account 001.121.5450.

**Section 4.** The City of Conway shall appropriate funds from Municipal Vehicle Program in the amount of \$674.83 from 001.119.4360 to the AWU vehicle maintenance expense account 001.127.5450.

**Section 5.** All ordinances in conflict herewith are repealed to the extent of the conflict.
