**City of Conway, Arkansas
Ordinance No. O-23-31**

**AN ORDINANCE AUTHORIZING A CHANGE IN STAFFING LEVELS FOR THE AIRPORT DEPARTMENT.
DECLARING AN EMERGENCY AND FOR OTHER PURPOSES:**

Whereas, the Airport Department has determined that it can more effectively and efficiently manage City property and resources through an increase in an additional position of support staff personnel, an Airport Line Technician, and

Whereas, the City Council has determined that there is a need for one (1) additional full time Airport Line Technician position in the Airport Department; and

Whereas, a budget adjustment in the amount of \$35,210 is required for the remainder of the 2023 budget year;

**NOW THEREFORE BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF CONWAY, ARKANSAS
THAT:**

Section 1. The authorized staffing level of the Airport Department is increased by one (1) full time Airport Line Technician position.

Section 2. Funds in the amount of \$35,210 are appropriated from the Airport Fund Balance Appropriation account (550.109.4900) to the appropriate salary and benefit accounts in the Airport Fund budget.

Section 3. All ordinances in conflict herewith are repealed to the extent of the conflict.

Section 4. This ordinance is necessary for the protection of the public peace, health and safety; an emergency is hereby declared to exist, and this ordinance shall be in full force and effect from and after its passage and approval.
