

RESOLUTION NO. R-78-56

A RESOLUTION AUTHORIZING THE CONWAY CORPORATION TO TEMPORARILY IMPLEMENT AN ALTERNATIVE RATE FOR SEWER SERVICE UNTIL SUCH TIME AS THE WASTEWATER TREATMENT PLANT NOW UNDER CONSTRUCTION BECOMES OPERATIVE.

WHEREAS, by Ordinance No. 0-76-18 the current sewer service charges were established, and

WHEREAS, by Ordinance 0-76-31 rates established by Ordinance 0-76-18 were pledged to secure a Sewer Revenue Bond Issue and said rates cannot be reduced until said bond issue is retired, and

WHEREAS, said rates are in conformance with requirements and guidelines of the Environmental Protection Agency as agreed to by the City in accepting a 75 percent grant for construction of a wastewater treatment plant, and

WHEREAS, the revenue requirements of the Sewer Department (including all debt service) will be less than those produced by Ordinance 0-76-18 and will remain so until said wastewater treatment plant becomes operative;

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF CONWAY, ARKANSAS:

THAT the Conway Corporation be allowed and is herewith directed to reduce the sewer service charges to conform to the rate schedule attached hereto and hereby made a part of this resolution until such time as said wastewater treatment plant becomes operative.

At such time as said wastewater treatment plant becomes operative, the Conway Corporation shall revert back to the rates set out in Ordinance 0-76-18.

Wastewater Collection Rate Schedule

Effective Date -

RESIDENTIAL SERVICE

Availability - At any point on the existing wastewater collection system within the city limits.

Application - "Residential customer" shall include any customer whose buildings or premises are utilized for one-family or two-family residential occupancy under one roof, or more than one-family residential occupancy under one roof where individual water meters are utilized for each dwelling unit therein.

Character of Service - Wastewater quality must be in conformance with Ordinance No. A-566.

For the purpose of determining the water consumption upon which these charges will be based, the average consumption during the immediate preceding November, December, January, February and March will be calculated in April of each year. Charge for the ensuing 12-month period will be based on this average consumption. In the case of new customers for whom consumption records for the months involved are not available, the consumption shall be on a fair basis, taking into consideration such records as are available.

Minimum - \$ 2.00 per month.

Payment - The net bill, computed in accordance with the net monthly rate, shall be due and payable upon presentation.

COMMERCIAL SERVICE

Availability - At any point on the existing wastewater collection system within the city limits.

Application - For service to any customer not classified as residential or industrial as defined in Section 1 (e) (1) and Section 1 (e) (2) of Ordinance No. 0-76-18.

Character of Service - Wastewater quality must be in conformance with Ordinance No. A-566.

INDUSTRIAL SERVICE

Availability - At any point on the existing wastewater collection system within the city limits.

Application - "Industrial customer" shall include any customer whose activities are identified in the Standard Industrial Classification Manual Bureau of the Budget 1967, as amended and supplemented, under the Category D - Manufacturing, or whose sewage effluent contains wastes with a strength greater than normal sewage as described in the City's Sewer Use Ordinance (Ordinance No. 566 as it may be amended from time to time.)

Character of Service - Wastewater quality must be in conformance with Ordinance No. A-566.

Net Monthly Rate - The greater of a charge computed on the following average water consumption (A) or a charge computed on the formula (B):

For the purpose of determining the water consumption upon which these charges will be based, the average consumption during the immediate preceding 12 months ending March 31 will be calculated in April of each year. In the case of new customers for whom consumption records for the months involved are not available, the consumption shall be on a fair basis taking into consideration such records as are available.

INDUSTRIAL SERVICE

(B) Formula: --  $ci = vo vi + bo bi + so si$

Where "ci" is equal to the charge to industrial customers: where "vo" is equal to the unit cost of transportation and treatment of industrial waste chargeable to volume, as shown in dollars per 1,000 gallons: where "vi" is equal to the volume of waste water from industrial customers: as shown in gallons per month: where "bo" is equal to the unit cost of treatment chargeable to Biochemical Oxygen Demand (BOD) as expressed in dollars per pound: where "bi" is equal to the amount of BOD from industrial customers, as expressed in pounds per month: where "so" is equal to the unit cost of treatment (including sludge treatment) chargeable to suspended solids, expressed in dollars per pound: and where "si" is equal to the amount of suspended solids from industrial customers as shown by pounds per month. In the utilization of such formula the costs associated with the transportation and treatment of industrial waste shall include the unamortized capital costs of existing facilities (as represented by the outstanding debt), new facility construction costs (exclusive of funds that do not have to be repaid) operation and maintenance costs (including repair and replacement costs), and any other costs borne by the City, including but not limited to site acquisition, easement costs and administrative costs.

Minimum - \$ 2.00 per Month or  
the charge computed on Formula (B) above.

Payment - The net bill, computed in accordance with the net monthly rate, shall be due and payable upon presentation.
