Pursuant to the City Council's request we published the following Notice – in the Arkansas Democrat Gazette, the Log Cabin Democrat and posted the same on the City of Conway website on Sunday, October 18, 2015:

Notice

The City of Conway is accepting sealed bids for group Health Benefits for the 2016 plan year. Bid information and specifications may be obtained at <u>www.cityofconway.org</u> on Monday, October 19<sup>th</sup>, by contacting the Office of the Mayor, 1201 Oak Street, Conway, AR 72032 or by calling 501-450-6110. Bids must be received in the Mayor's Office no later than 10:00 a.m. on November 2<sup>nd</sup>, 2015 to be considered.

We received requests for and provided <u>Employee Census Reports</u>, <u>2015 January through September Experience Report</u> (<u>Claims vs. Premiums</u>), <u>2015 Claims Paid by Service Code</u>, <u>2015 Claims Paid by Diagnosis Code</u>, <u>2015 Large Claims Reports</u>, <u>2015 Top 10 Drug Reports</u>, <u>2013, 2014, 2015 Medical Benefits Rates</u>, <u>AML MHBF 2016 rates</u>, <u>2014 Claims vs. Premiums</u> <u>Report</u>, and <u>2012/2013 Claims vs. Premiums Reports</u>. Representatives from Health Advantage and Legacy Capital Group – a Benefits Consultant, requested the reports.

On Friday afternoon I received an email from the Legacy Capital Group consultant stating that she had received a "decline to quote" from all carriers they represent. I also received a phone call from the Health Advantage representative stating that his underwriters were declining to quote because they were unable to present a competitive quote.

The Arkansas Municipal League will only offer two tiers in 2016, Employee and Employee plus Family. The attached spreadsheets shows several scenarios of the cost to the City if the percentage the City contributes toward the Employee plus Family tier is changed.

We respectively request that you approve the renewal of our contract with the Arkansas Municipal League Health Benefit Fund to continue to provide medical benefits to City of Conway employees for the 2016 plan year. We also request that you determine if the City's Employee plus Family percentage contribution will change for the 2016 plan year.

- 2. That the City Clerk is hereby directed to publish notice of the filing of said petition and of said hearing for the time and in the matter prescribed by law.



Because you failed or refused to remove, abate or eliminate certain conditions on the aforementioned real property in the City of Conway, after having been given seven (7) days notice in writing to do so, the City of Conway was forced to undertake the cleanup of this property to bring it within compliance of the Conway Municipal Code.





Section 2: The rate of taxation levied herein on the real and personal property within the city shall, by this Resolution, be certified to the County Clerk to be placed upon the tax books and collected in the same manner that the state and county taxes are collected.

#### A RESOLUTION AUTHORIZING THE MILLAGE RATE OF PROPERTY TAX FOR THE CITY OF CONWAY, ARKANSAS FOR THE YEAR 2015 TO BE COLLECTED IN 2016

Whereas, Ark. Code Ann. § 26-25-102 provides that a city may levy a tax on the real and personal property located within the city for the purpose of raising <u>General Fund revenues</u> in any one year, pursuant to the provisions of the Arkansas Constitution; and

Whereas, Ark. Code Ann. § 26-73-202 requires the City Council of any municipal corporation to make out and certify to the county clerk the rate of taxation levied by the city on all the real and personal property within the city; and

Whereas, the City Council has determined that it is in the best interests of the City of Conway and its citizens to levy the rate of taxation on the real and personal property located within the said city as set forth herein, and to certify the same to the County Clerk, and authorize the Quorum Court of Faulkner County to levy said tax for the year 2015 to be collected in 2016.

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF CONWAYE, ARKANSAS:

Section 1: The property tax rate for the City of Conway <u>General Fund Revenue</u> on the real and personal property situated within the city and to be collected in the year 2016 shall be fixed and levied at the rate of <u>Three (3.0) mill</u> on each dollar of assessed value of real and personal property.
