

Said funds are to support the City of Conway's Historic District Commission's effort in a resurvey of the Conway Commercial National Register of Historic Places Historic District and expenses related to training opportunities; and

Whereas, No payment has been made by the AHPP to the City of Conway commencing this work. This money was appropriated before work started on the projects herein and the AHPP works on a reimbursement scale for payment after all projects once the grant has been completed; and

Whereas, Since the passage of the original ordinance, the AHPP has amended the terms of the initial Certified Local Government grant to add an additional \$14,500 to the existing amount, making the current overall sum to be \$35,143.75, furthering the need to rescind the initial appropriation ordinance.

## NOW, THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF CONWAY, ARKANSAS THAT:

**Section 1:** That Ordinance O-21-49 is hereby rescinded.

**Section 2:** The City of Conway, Arkansas, shall move said funds in the amount of \$20,643.75 back to the State Grant Revenue (399-000-4751) from Other Misc Expenses (399-105-5799).

Re: Ordinance to Rescind O-21-49

The City of Conway received funds for the 2021 Certified Local Government grant that will be fulfilled during the 2022 calendar year. The funds in the amount of \$20,643.75 were appropriated at the April 27, 2021, City Council meeting. These funds are for the resurvey of the Conway Commercial National Register of Historic Places Historic District and expenses related to training opportunities for Historic District Commission staff.

Although these funds were appropriated from the State Grant Revenue fund to the Planning Department Grant fund, payment was not made by the AHPP as they work on a reimbursement scale for payment after work has been completed. This ordinance will in essence move that \$20,643.75 amount back to the State Grant Revenue fund and Planning staff will pay for the grant outright and be reimbursed after all work for the 2021 CLG grant has commenced.

Additionally, the AHPP has amended the terms of the initial Certified Local Government grant to add an additional \$14,500.00 to the existing amount for the resurvey of the Hendrix College Addition National Register of Historic Places Historic District. This increases the funds of the 2021 CLG grant to \$35,143.75, which furthers the inaccuracy of the O-21-49 appropriation ordinance.
