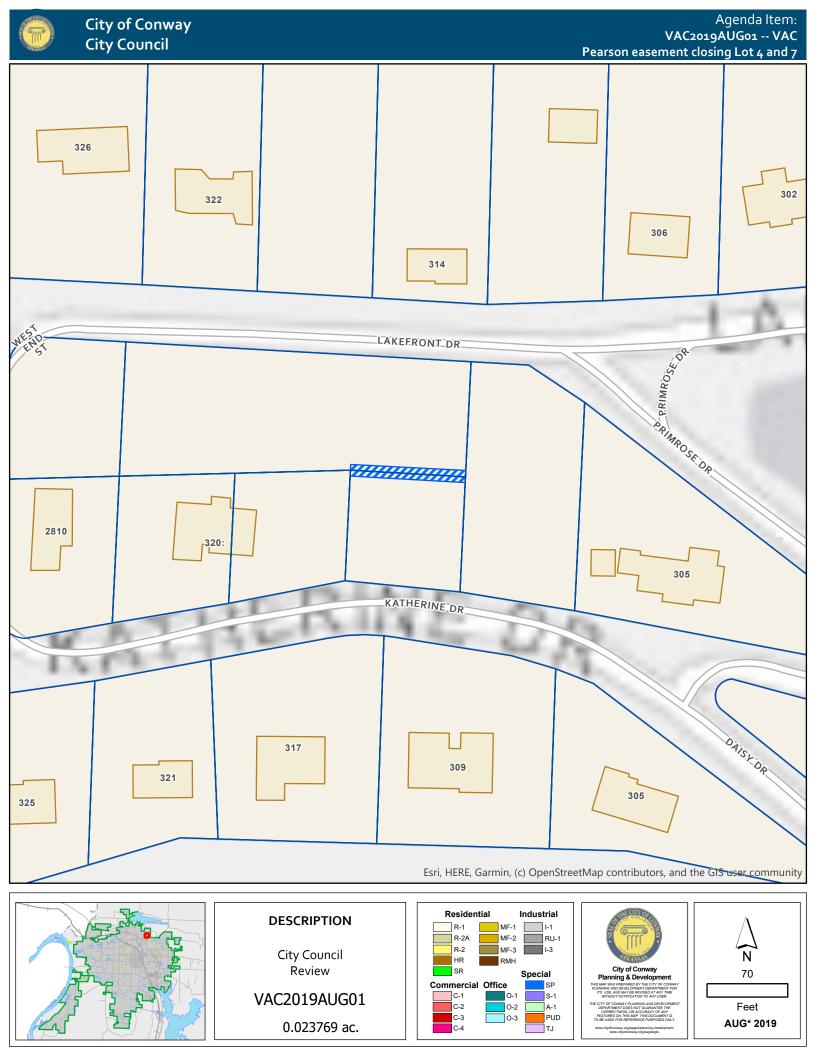

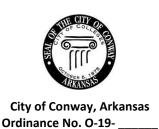

Under the Department's Intersection Improvement Program, preliminary engineering, construction and construction engineering phases of this project are eligible for 80% Federal-aid funding (\$350,000 maximum available Federal-aid) with the remaining 20% split between the Department (10%) and the City (10%). The City would be responsible for 100% of the cost for any necessary right-of-way acquisition or utility relocation. As shown on the enclosed cost estimate, the City's estimated total project cost would be \$1,335,550. This does not include an estimated \$251,000 in utility relocation within the existing right of way. Individual utility companies may be required to cover these relocation costs. Please note that this is a planning-level estimate and that the costs may change as design of the project progresses.
