# City of Conway, Arkansas Ordinance No. O-15-\_\_\_\_

# AN ORDINANCE CLOSING THE ALLEY IN BLOCK 79 BOULEVARD ADDITION, CITY OF CONWAY; AND FOR OTHER PURPOSES;

**Whereas,** a petition was duly filed with the City Council of the City of Conway, Arkansas on the 8<sup>th</sup> day of September, 2015 asking the City Council to vacate and abandon the alley in Block 79, Boulevard Addition running south from South Boulevard to Robins Street.

Whereas, after due notice as required by law, the council has, at the time and place mentioned in the notice, heard all persons desiring to be heard on the question and has ascertained that the alley or the portion thereof, hereinbefore described, has heretofore been dedicated to the public use as an alley herein described; has not been actually used by the public generally for a period of at least five (5) years subsequent to the filing of the plat; that all the owners of the property abutting upon the alley to be vacated have filed with the council their written consent to the abandonment; and that public interest and welfare will not be adversely affected by the abandonment of this alley.

#### NOW, THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF CONWAY ARKANSAS:

**Section 1.** The City of Conway, Arkansas releases, vacates, and abandons its rights, together with the rights of the public generally, in and to the alley in Block 79 in the Boulevard Addition, with the exception that the alley will be <u>retained for Conway Corporation the 20 foot utility easement centered on the existing sewer main and electric lines existing in the alleyway; AT&T a dedicated ten foot utility <u>easement to encompass AT&T existing facilities; and Centerpoint will maintain a 20 foot utility easement as it owns and maintains a 2 inch plastic gas main; designated as follows:</u></u>

THE TWENTY FOOT (20') ALLEY LOCATED IN BLOCK 79 OF THE BOULEVARD ADDITION RUNNNING SOUTH FROM SOUTH BOULEVARD TO ROBINS STREET.

**Section 2.** A copy of the ordinance duly certified by the city clerk shall be filed in the office of the recorder of the county and recorded in the deed records of the county.



A RESOLUTION SETTING A PUBLIC HEARING TO DISCUSS THE CLOSING OF AN ALLEY IN BLOCK 22 OF THE ROBINSONS PLAN, IN THE CITY OF CONWAY, ARKANSAS.

**Whereas,** a petition has been filed with the City Council of the City of Conway, Arkansas by Conway Corporation to abandon an alley in Block 22 of the Robinsons Plan of the City of Conway; and

Whereas, upon the filing of the petition with the City, the City shall set a date and time for a hearing before the City Council for consideration of the petition.

The City of Conway would like to move forward with selecting a Qualified Environmental Professional Firm (QEP) – FTN & Associates. This firm was the Arkansas Department of Environmental Quality's CSA (Comprehensive Site Assessment) contractor for the Conway Scrap Metal Site, and their knowledge of the site is an important resource for developing a Cleanup Plan for this project. FTN & Associates being procured by ADEQ for the CSA, as well as being on the State Contractor list of approved QEP's – meets competition and state procurement rules.

This contract and recommendation to utilize FTN & Assoc. comes out of review by our Quality Assurance Manager, Jack Branscum, myself, Program Manager, and other city officials providing oversight on this project including, Ronnie Hall, City Engineering and Wes Craiglow, City Planning. # Scope of Work Preparation of Brownfields Clean Up Plan Former Conway Scrap Metal Brownfields Site Conway, Faulkner County, Arkansas

Attached to and made part of the letter agreement dated September 17, 2015, between FTN Associates, Ltd. (FTN) and the City of Conway, Arkansas (the Client) with respect to the Project described therein. Project tasks, assumptions and limitations follow.

#### BACKGROUND

The City of Conway, Arkansas, has acquired the former Conway Scrap Metal site and entered the property into the Arkansas Department of Environmental Quality (ADEQ) Brownfields program. As part of the ADEQ Brownfields program a Phase I Environmental Site Assessment (ESA) and a Comprehensive Site Assessment (CSA) have been completed for the site. These investigations determined that environmental contamination exists in the shallow soils and groundwater at the site. Additionally, the City of Conway has received clean up funding for the former Conway Scrap Metal Brownfields site from the US Environmental Protection Agency (EPA) Region 6 Brownfields program. The City intends to redevelop the site for public use and is seeking assistance with development of a Clean Up Plan for the site. The following Scope of Work outlines the required tasks for development of the Clean Up Plan.

#### PROJECT TASKS

#### TASK 1 — REVIEW OF EXISTING DATA

FTN staff will revisit and review the data and information regarding the previous investigations at the site. Additionally, FTN will review the Property Development Plan (PDP), Analysis of Brownfields Cleanup Alternatives (ABCA), the Implementing Agreement (IA) and schedule as developed by others.

#### TASK 2 — DEVELOPMENT OF CLEANUP PLAN DOCUMENT

FTN will prepare a Clean Up Plan that will include the following information:

- Site Background Information
- Results of the CSA
- Proposed Remedial Alternatives
- Selected Remedial Technology
- Proposed Remedial Goals
- Clean Up Implementation Schedule
- Conclusions and Recommendations

FTN will prepare a draft Clean Up Plan for review by the City of Conway. Upon receipt of comments from the City, FTN will finalize the Clean Up Plan and prepare copies for submittal to ADEQ and EPA.

#### TASK 3 — AGENCY REVIEW COORDINATION

Due to the fact that contaminants identified at the site include Resource Conservation and Recovery Act (RCRA) hazardous materials and Toxic Substance and Control Act (TSCA) regulated polychlorinated biphenyls (PCBs), the Clean Up Plan will be submitted to ADEQ, the EPA Region 6 Brownfields program and the EPA Region 6 TSCA program for review and approval. This task includes FTN labor for preparation of materials for submittal to all groups as well as for responding to questions from ADEQ and EPA. Any required revisions to the Clean Up Plan, collection and analysis of samples or other additional work that may be requested by ADEQ and/or EPA during review of the Clean Up Plan will be considered "Additional Services" by FTN and will be billed accordingly. Additional Services will be billed according to Fee Schedule included in Exhibit C.

### TASK 4 — DEVELOPMENT OF QUALITY ASSURANCE PROJECT PLAN

FTN will develop a Quality Assurance Project Plan (QAPP) that will document planning and implementation procedures for the Conway Scrap remediation project. The QAPP will integrate all the technical and quality assurance aspects of the project in order to provide a "blueprint" for obtaining the type and quality of environmental data and information needed for a specific decision or use. Specific items in the QAPP will include activities such as sample collection for waste profiling, laboratory analytical methods, field documentation and procedures for reporting.

#### TASK 5 — COORDINATION

Under this task, FTN will provide the necessary project management and coordination with the Client, ADEQ and EPA to successfully complete the Project.

#### PROJECT SCHEDULE

FTN has developed a proposed project schedule for completion of the entire project to meet the goals of the City of Conway. It should be noted that a number of the tasks involve reviews by both state and federal regulatory agencies. The time for these reviews have been estimated based upon our experience with past projects. Actual review and approval times may fall outside the anticipated timeframes. This Scope of Work covers Tasks 1 through 6 on the Estimated Project Schedule included with this proposal as Exhibit D.

- 1. Client will provide timely responses to information requests by FTN,

There is hereby excepted from the foregoing any and all liability and claims of liability solely attributable to acts of CLIENT's direct payroll employees, and there is hereby further excepted from the foregoing any and all liability and claims of liability for environmental pollution which are not the result of negligence on the part of FTN in FTN's performance of this contract.
- b. CLIENT does hereby indemnify and save harmless FTN from and against any and all liability and claims of liability of any and every kind and nature including without limitation bodily injury, death, property damage and claims for environmental pollution which are not the result of negligence on the part of FTN in FTN's performance of this contract, and CLIENT, at CLIENT's sole expense, shall handle all such claims, defend all lawsuits filed against FTN on account thereof, pay all judgments rendered against FTN therein, and reimburse FTN in cash for all reasonable expense incurred by FTN on account thereof, provided, that if FTN elects

to retain independent counsel, CLIENT shall reimburse FTN for all costs reasonably incurred by FTN to defend itself through attorneys of FTN's choice.

5. <u>Electronic Deliverables</u> Any use or reuse of original or altered computer files by CLIENT or others without written verification by FTN for purposes other than for the specific purpose intended will be at CLIENT's risk and full legal responsibility. Furthermore, CLIENT will, to the fullest extent permitted by law, indemnify and hold FTN harmless from any and all claims, suits, liability, demands, or costs arising out of or resulting therefrom. Any verification of such adaptation by CLIENT will entitle FTN to additional compensation at the then current rate.

# AN ORDINANCE APPROPRIATING FUNDS FOR THE PURCHASE OF SOFTWARE FOR LAND-USE, PERMITTING, AND CODE ENFORCEMENT; AND FOR OTHER PURPOSES

**Whereas**, a Request for Proposals was issued in October of 2014, and responses have been reviewed and carefully analyzed; and

Whereas, Accela has been chosen as the vendor with the product that best suits the City's needs; and

Whereas, the City wishes to utilize impact fee revenue for the purchase and ongoing technical support; and

**Whereas**, Article VI, Section 12, Provision L(4) of the City's Subdivision Ordinance shall serve as the authority for utilizing 2% of annual impact fee revenue for the ongoing technical support; and

**Whereas**, in years that 2% of impact fee revenue is not sufficient to pay the ongoing technical support, the Planning Department budget will cover the remaining cost.

## NOW, THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF CONWAY, ARKANSAS THAT:

**Section 1.** For the purchase of the software, the City of Conway shall appropriate \$47,875 from the Parks Impact Fund Balance Appropriation account (652.140.4900) to the Computer Equipment/Software account (652.140.5930), and also shall appropriate \$47,875 from the Street Impact Fund Balance Appropriation account (651.201.4900) to the Computer Equipment/Software account (651.201.5930), for the total purchase price of \$95,750.

**Section 2.** For the first two years' subscription and technical support costs (prepaid to receive a discount), the City of Conway shall appropriate \$41,290.17 from the Parks Impact Fund Balance Appropriation account (652.140.4900) to the Software Maintenance account (652.140.5420), and also shall appropriate \$41,290.17 from the Street Impact Fund Balance Appropriation account (651.201.4900) to the Software Maintenance account (651.201.5420), for the total two year subscription price of \$82,580.34

**Section 3.** All ordinances in conflict herewith are repealed to that extent of the conflict.

The policy shall be endorsed to include a waiver of subrogation in favor of the Listed Parties and their affiliated and associated companies.

- (b) Commercial General Liability Insurance including Contractual Liability Coverage, covering liability assumed (including, but not limited to, liability of City), Contractor's Protective Liability Coverage for work sublet, Products/Completed Operations Coverage, Broad Form Property Liability Coverage, Personal Injury Liability Coverage and Explosion, Collapse and Underground "XCU" Hazards, in the amount of not less than \$1,000,000 per occurrence *I* \$2,000,000 aggregate for Bodily Injury and Property Damage applying to the job location where work is performed for or on behalf of City or Franchisee.
- (c) Commercial Automobile Liability Insurance including all owned, hired, leased, borrowed, assigned and non-owned vehicles, in the amount of not less than \$1,000,000 per occurrence.
- (d) Excess/Umbrella Liability Insurance following the form of the liability insurance as required in paragraphs (a), (b) and (c) above, in the amount of not less than \$5,000,000 per occurrence.

The insurance coverage hereunder shall be obtained through insurance companies licensed to do business in

Arkansas and rated not inferior than A-\X according to Best's Insurance Reports. In addition, all policies shall provide that each named additional insured shall receive not less than thirty (30) days prior written notice from the insurer in the event any of the required insurance is to terminate, lapse or expire.

The insurance shall not terminate prior to the completion of the work on this project.

The additional insurance as described herein will be measured as a Lump Sum item and paid for at the Unit Price per Lump Sum for "Additional Liability Insurance Coverage" as listed in the UNIT PRICE SCHEDULE shown below.

Revise SECTION E-1 – SITE PREPARATION to add paragraph E1-2.8 and revise paragraph E1-3.1 to read as follows:

E1-2.8 ADDITIONAL WORK FOR 9<sup>th</sup> AVENUE CONNECTION: The site preparation work required for the added of the extension of 9<sup>th</sup> Avenue across the old runway to connect to 6<sup>th</sup> Street shall be in accordance with the provisions included in this section. The work shall include some drainage modifications as noted on the plans and as directed in the field by the engineer. The additional quantities for earthwork, undercut, crushed stone, asphalt, storm drainage pipe and other unit quantity items in the Unit Price Schedule shall be paid for by including the added quantities in the payment estimate as they are completed.

Work completed and accepted under this item will be paid for at the contract lump sum price bid for "SITE PREPARATION," which price shall be full compensation for furnishing all labor, tools, equipment and incidentals necessary to complete the work.

The Site Preparation work for required for the added 9<sup>th</sup> Avenue Extension to 6<sup>th</sup> Street work will be measured as a lump sum complete item and paid for at the contract lump sum price shown in the Unit Price Schedule below for "Site Preparation 9<sup>th</sup> Avenue Connection", which price shall be full compensation for furnishing all labor, tools, equipment and incidentals necessary to complete the work.

The modification of the storm drainage pipe and ditches as shown on the plans or as directed in the field by the engineer for the added 9<sup>th</sup> Avenue Extension to 6<sup>th</sup> Street work will be measured as a lump sum complete item and paid for at the contract lump sum price shown in the Unit Price Schedule below for "9<sup>th</sup> Avenue Drainage Modification", which price shall be full compensation for furnishing all labor, tools, equipment and incidentals necessary to complete the work.

Bids were received for the "Hwy. 64 Intchng. Traffic Operation Impvts. (Conway) (S)" project at 1201 Oak Street, Conway, Arkansas, 72032 at 10:30 a.m. on September 3, 2015. The bids have been checked for accuracy and for compliance with the contract documents. A tabulation of the bids received is enclosed with this letter.

A total of two bids were received for the project. Mobley Contractors, Inc. submitted the low bid in the amount of \$5,283,458.30.

Mobley Contractors, Inc. bid a total amount of \$13,083.84 for 4' Steel Chain Link Fence (Alternate No. 1), and a total amount of \$29,106.00 for 4' Aluminum Chain Link Fence (Alternate No. 2). These items include 924 linear feet each and were intended to be alternate bid items. We want the City of Conway to be aware that the contract amount will reduce by either \$13,083.84 or \$29,106.00 depending on the type of fence used.

The enclosed bid tabulation presents the Opinion of Probable Construction Cost based on AHTD weighted average unit prices for 2014. These unit prices likely do not reflect added costs associated with the high volume of traffic on Hwy. 64 (Oak Street), nor does it reflect added costs associated with several narrow pavement widening challenges that are included in this project.

We believe that the bid submitted by this company represents a good value for the City of Conway. We recommend that the construction contract for the "Hwy. 64 Intchng. Traffic Operation Impvts. (Conway) (S)" be awarded to Mobley Contractors, Inc. We are available to discuss this recommendation and a date for their notice to proceed at your convenience.

ORDINANCE FOR THE PURPOSE OF RECLASSIFYING ONE ADMINISTRATIVE ASSISTANT I POSITION WITHIN THE OFFICE OF THE CITY ATTORNEY AS A DEPUTY CITY ATTORNEY POSITION; TO APPROPRIATE ADDITIONAL FUNDS FOR THE PAYMENT OF SALARY, BENEFITS AND OTHER COSTS OF AND FOR THAT RECLASSIFIED POSITION; TO RETITLE THE ALREADY EXISTING DEPUTY CITY ATTORNEY POSITION; TO DECLARE AN EMERGENCY; AND FOR OTHER PURPOSES

Whereas, the staff of the Office of the City Attorney currently consists of one (1) full-time elected City Attorney, one (1) full-time Deputy City Attorney position, one (1) full-time Law Office Administrator Position, and two (2) full-time Administrative Assistant I positions; and

**Whereas,** one (1) Administrative Assistant I position within the Office of the City Attorney will become vacant on September 25, 2015, due to the resignation of its current occupant; and

Whereas the City Council has determined that, due to the continuing rapid growth of the City of Conway and consequent increase in legal issues presented to the City, there is an immediate need to add one (1) additional full-time Deputy City Attorney position to the staff of the Office of the City Attorney, and that so doing will require expenditure of additional funds to secure a qualified attorney for that position; and

Whereas, the City Council has determined that the immediate need for one (1) additional full-time Deputy City Attorney position outweighs the need to fill the Administrative Assistant I position to be vacated on September 25, 2015; and

Whereas, the City Council has determined that the City Attorney's ability to effectively represent the City of Conway in both civil and criminal matters depends upon the City Attorney's office being adequately staffed, and that adequate attorney staffing is therefore essential to the protection of the public peace, health and safety;

**Whereas,** the 2015 General Fund budget for the City of Conway was adopted absent the necessary funds to implement the increased salary, benefits and other costs necessary to attract and secure a qualified attorney for position to be reclassified as a second full-time Deputy City Attorney,

#### NOW THEREFORE BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF CONWAY, ARKANSAS THAT:

- **Section 1.** One (1) full-time Administrative Assistant I position within the Office of the City Attorney is hereby reclassified as a second full-time Deputy City Attorney position.
- **Section 2.** The full-time Deputy City Attorney position hereby created shall be filled by an attorney licensed to practice law in the State of Arkansas, whose Arkansas law license is in good standing. The attorney occupying the full-time Deputy City Attorney position hereby created shall report to and serve at the will of the City Attorney. The job description applicable to the full-time Deputy City Attorney position hereby created shall be comparable to that of the already existing full-time Deputy City Attorney position.
- **Section 3.** The salary for the full-time Deputy City Attorney position hereby created shall be \$44,500 per year, and the attorney occupying that position shall be eligible to receive any and all benefits associated with full-time employment with the City of Conway.

- **Section 4.** Any remaining funds allocated in the 2015 budget for payment of salary, benefits and other costs for the Administrative Assistant I position now being reclassified as full-time Deputy City Attorney are hereby reallocated to the payment of salary, benefits and other costs of the Deputy City Attorney position hereby created for the remainder of 2015.
- **Section 5.** In addition to the funds reallocated in Section 4, the City of Conway shall appropriate \$3,866.64 from the General Fund Balance account (001.119.4900) to the appropriate salary and benefit expense accounts necessary to fully fund the Deputy City Attorney position hereby created at the yearly salary stated in Section 3 for the remainder of 2015.
- **Section 6.** The Deputy City Attorney position that existed prior to this ordinance is hereby retitled as the Chief Deputy City Attorney position.
- **Section 7.** That any ordinance which conflicts with this ordinance is hereby repealed to the extent of the conflict.
- **Section 8.** This ordinance is necessary for the protection of the public peace, health and safety; an emergency is hereby declared to exist, and this ordinance shall be in full force and effect from and after its passage and approval.

Radio System Vendor Recommendation

Technology changes exponentially making it almost impossible to stay current with the latest technology. On July 1, 2015 the City of Conway published a Request for Proposal (RFP) to purchase a modern and integrated state-of-the-art wide area voice network for use throughout the City of Conway utilizing Project 25 Phase 2 trunked technology. By the close of business, August 12, 2015 2 vendors had submitted responses to the RFP, Motorola Inc. \$2,995,839.00, and Harris Corporation \$2,975,000.00. Both vendors submitted proposals for a standalone system with interrogation to the Arkansas Wireless Information Network (AWIN) Motorola also proposed a secondary proposal, AWIN expansion.

After reviewing the RFP, meeting with both vendors, the committee traveled to Russellville to observe a Motorola system and speak to current users of the Motorola system. Later the committee traveled to Broken Arrow, OK to observe a Harris system and spoke to current users of the Harris System. On September 8<sup>th</sup> 2015 Motorola presented their solution, and on September 10, Harris presented their solution.

After much discussion the committee came to the conclusion that Harris is the logical choice for the city of Conway. Some of the reasons the committee selected Harris are; The overall cost of a Harris system is 20K less than Motorola; Harris proposed a 10 channel system opposed to a 7 channel system; Harris handheld radios are \$525.00 less than Motorola; Harris mobile radios are \$780.00 less than Motorola; and Dispatch workstations are a 1 piece solid state device, opposed to having a PC as part of the workstation. The overall consensus of the committee was that Harris technology was more cutting edge and would allow the city to take advantage of new technology and system growth.

The Communications Committee members were Mayor Tab Townsell, Chief of Staff Jack Bell, Alderman Mark Ledbetter, Fire Chief Mike Winters, Asst. Fire Chief Bill Keathley, Police Chief AJ Gary, Major Jody Spradlin, Major William Tapley, Major Larry Hearn, CTO Lloyd Hartzell, Network System Administrator Jeff West, and Dispatch Supervisor Brian Edwards.
