**At its meeting the Conway City Council took the following actions:**

**Ordinances Passed:**

- Ordinance {O-09-42} authorizing a franchise agreement with Arkansas Research an Education Optical Network (ARE-ON), **Vote 8-0**
- Ordinance {O-09-43} to allow restricted office in residential zones by conditional use permit. **Vote 8-0**
- Ordinance {O-09-44} authorizing a street-railroad crossing project for the elimination and installation of certain crossings within the City of Conway. **Vote 7-1 w/ Alderman Vaught voting against.**
- Ordinance {O-09-45} accepting assets valued at \$520 obtained through court order for the Conway Police Department. **Vote 8-0**
- Ordinance {O-09-46} appropriating grant funds in the amount of \$16, 632.68 for bullet proof vest to the Conway Police Department. **Vote 8-0**
- Ordinance {O-09-47} waiving bids and appropriating funds in the amount of \$22,474 in conjunction with hardware and software maintenance for the AS/400. **Vote 8-0**

- Approved accepting the bids from J'S Construction in the amount of \$974,027.61 for Meadows Corporate Center improvements – Meadows North entrance – Nina Russ Lane. **Vote 8-0**
- Approved to destroy certain employee records of the Conway Police Department. **Vote 8-0**
- Approved entering into an agreement with JPMS/Cox to perform the City's annual financial audit. **Vote 8-0**
