At its meeting the Conway City Council took the following actions:

Ordinances Passed:

- Ordinance {O-09-63} changing Trey Lane to Artis Lane within the City of Conway limits. **Vote 7-0 w/ Alderman Grimes not present**
- Ordinance {O-09-64} appropriating funds in the amount of \$8600 for participation in a collision avoidance training program for the Conway Police Department. **Vote 7-0**

Resolutions Passed:

- Resolution {R-09-24} setting a public hearing for the next regular scheduled City Council meeting, June 9th, 2009, to discuss the closing of a 15' utility easement running North and South along the east lot line of Lot 33 and the west lot line of 34 in Deerbrook Subdivision. **Vote 7-0**
- Resolution {R-09-25} authorizing the City of Conway to apply to be designated as a Preserve America Community. **Vote 7-0**
- Resolution {R-09-26} authorizing the Conway Parks Department to utilize federal aid recreational funds from the AR Highway Department. **Vote 7-0**

- Approved to amend the Conway Towne Center PUD (C-4) to allow a larger theater for property located at 201 Skyline Drive. **Vote 7-0**
- Approved to amend the Scherman Heights PUD (C-2) to allow an eating place with drive through located at 605 Salem Road. **Vote 7-0**

- Approved a conditional use permit for an insurance office in R-2A for property located at 919 Donaghey Ave. **Vote 7-0**
- Approved to name Salter Construction as the prospective applicant and to proceed with negotiating for fees for the new fairgrounds facility. **Vote 7-0**
