On this date the City Council of the City of Conway, Arkansas met in regular session. The following members being a quorum, were present and acting; Alderman Hawkins, Alderwoman Smith, Alderwoman Mehl, Alderman Vaught, Alderman Rhodes & Alderwoman Whitmore. Also, present and acting: Mayor Tab Townsell, City Clerk/Treasurer Michael Garrett, and City Attorney Michael Murphy. Alderman Grimes was not present.

At its meeting the Conway City Council took the following actions:

Ordinances Passed:

- Ordinance {O-10-52} closing a utility easement located at 3255 Miller's View (between Lots 11 & 12). **Vote 7-0 w/ Alderman David Grimes not present.**
- Ordinance {O-10-53} appropriating funds in the amount of \$5,993 for additional surveillance camera at District Court. **Vote 7-0**
