*On this date the City Council of the City of Conway, Arkansas met in regular session. The following members being a quorum were present and acting; Alderman Hawkins, Alderman Grimes, Alderwoman Smith, Alderwoman Mehl, Alderman Vaught, Alderman Rhodes, & Alderwoman Whitmore. Also, present and acting: Mayor Tab Townsell, City Clerk/Treasurer Michael Garrett, and City Attorney Michael Murphy. Alderman Jones was not present.*

***At its meeting the Conway City Council took the following actions:***

**Ordinances Passed:**

- Ordinance {O-10-136} to rezone property located at 3350 Irby Drive from R-2 to PUD. **Vote 7-0**
- Ordinance {O-10-137} appropriating and accepting restitution funds and accepting grant funds for the CPD. **Vote 7-0.**
- Ordinance {O-10-138} adopting the FY2011 City of Conway budget.
  - Motion to suspend the rules and bring forward to vote on. **Vote on 6-1 w/ Alderman Vaught voting against.**
  - Motion to amend the ordinance with a decrease of the General Fund by \$100,000. **Vote 6-1 w/ Alderman Rhodes voting against.**
  - Motion to pass the ordinance with the amended amount as stated by Council. **Vote 5-2 with Alderman Vaught and Alderwoman Smith voting against.**
  - Emergency clause: **Vote 7-0**

- Approved to accept the bid from Diamond International for a Hook lift Roll-off Truck in the amount of \$122,100 for Conway Sanitation Department. **Vote 7-0**
