On this date the City Council of the City of Conway, Arkansas met in regular session. The following members being a quorum were present and acting; Alderwoman Mehl, Alderwoman Smith, Alderman Hawkins, Alderman Grimes, Alderman Vaught, Alderman Rhodes, Alderwoman Whitmore & Alderman Jones. Also, present and acting: Mayor Tab Townsell, City Clerk/Treasurer Michael Garrett, & City Attorney Michael Murphy.

Ordinance Passed:

- O-11-72 Ordinance to close a 10 foot utility (waterline) easement located within The Village at Hendrix, Multi-Family Rowhouse units. **Vote 8-0**
- O-11-73 Ordinance changing the street name of the section of Elm Street between the railroad and Harkrider Street to College Avenue. **Vote 8-0**
- O-11-74 Ordinance accepting grant proceeds received from Walmart in the amount of \$2000 and appropriating those funds received for the Conway EcoFest 2011. **Vote 8-0**
- O-11-75 Ordinance revising the Blue Ribbon Commission rules and regulations for City Boards & Commissions. **Vote 7-1 w/ Alderman Vaught voting against.**
- O-11-76 Ordinance closing the southernmost 250 feet of Simon Street (unpaved) located at 650 Simon Road. **Vote 5-3 w/ Alderman Rhodes, Alderwoman Smith, Alderman Whitmore voting against & Mayor Townsell voted with the majority. (Alderman Jones was not present)**
- O-11-77 Ordinance clarifying procedures by which fees, surcharges and revenues are assessed for residential and commercial trash pick-up for the Conway Sanitation Department. **Vote 7-0**
- O-11-78 Ordinance redistricting the City of Conway Council Wards; and setting new ward boundaries for the City. **Vote 7-0**
- O-11-79 Ordinance authorizing the Mayor to enter into a settlement agreement; and appropriating funds for the City of Conway. **Vote 7-0**

Resolution Passed:

- R-11-49 Resolution requesting the Faulkner County Tax Collector to place a certified lien on 1515 Freyaldenhoven as a result of incurred expenses by the City. **Vote 8-0**
- R-11-50 Resolution expressing the willingness of the City of Conway to partner with the AHTD for the relocation of Hwy. 25. **Vote 7-0 w/Alderman Jones not present.**

In Other Actions:

- Approved the minutes from the September 13th, 2011 City Council meeting. **Vote 8-0**
- Approved the request from the Health Facilities Board to reappointment Michael Garrett to a 4 year term and Fletcher Smith to a 5 year term. **Vote 8-0**
- Approved to reappointment Angela Bagby to another 4 year term on the A&P Commission. **Vote 8-0**
- Approved the conditional use permit for Robinson and Center Church of Christ Church to allow religious activities for property located at 1505 Robinson Avenue. **Vote 7-0**
- Approved to enter into an agreement with Pitney Bowes for mailing services for the City. **Vote 7-0**
- Approved the renewal of the contract for our voluntary benefits provider Benefit/Partners/Flexco for the 2012 Plan year. **Vote 7-0**
- Approved a conceptual easement for CenterPoint Energy for a Pipeline Reroute. **Vote 7-0**

- Ordinance to close a portion of College Ave, Front St, Elm St, and Chestnut St right of ways. **Vote 7-0**
- Resolution accepting the recommendation from the Conway Citizen Taskforce Committee. **Vote 7-0**
