Ordinances Passed:

- O-17-18 Ordinance to vacate and abandon the fifteen foot utility easement located along the eastern property line on Lot 2, Acxiom commercial addition. **Vote 7-0**
- O-17-19 Ordinance renaming a portion of 8th Avenue to Central Landing Blvd. **Vote 7-0**
- O-17-20 Ordinance appropriating grant funds in the amount of \$5,586.85 for the Spencer Street Brownfield Cleanup project. **Vote 8-0**
- O-17-21 Ordinance to rezone property located at Winterbrook Subdivision, Phase 2 in the 3300 Block of Tyler Street from A-1 to R-1. **Vote 8-0**
- O-17-22 Ordinance to provide short term financing from First Security Bank with an interest rate of 3.07% for the construction improvements to the Conway Expo & Event Center. **Vote 8-0**

- Approved First Security Bank interest rate in the amount of 3.07% for the completion of the Expo Center and Fairground. **Vote 8-0**

Approved Bid from 3 South LLC in the amount of \$34,849.25 for an identiFINDER for the Conway Fire Department Bomb Squad. **Vote 8-0**

Approved To remove to retire a K-9 dog (Dax) and remove from inventory and give to his handler Officer Shumate for the Conway Police Department. **Vote 8-0**
