- O-19-66 Ordinance amending the net metering rules and regulations for Conway Corporation. *Vote 7-0-1 w/ Alderwoman Mehl abstaining.*
- O-19-67 Ordinance appropriating matching funds in the amount of \$713,000 and accepting the lowest bid from Fureigh Heavy Construction in the amount of \$2,113,620.40 for the Markham Street Jump Start Project Federal Aid Program funds. *Vote 8-0*
