Ordinances Passed:

- O-18-107 Ordinance amending Ordinance No. O-15-88 clarifying the legal description of the Spruce Street Cottage Courtyard project. **Vote 7-0**
- O-18-108 Ordinance rezoning properties located on Robinson, Western, Louvenia, and Donaghey Avenues from R-2A and O-2 to S-1. **Vote 7-0**
- O-18-109 Ordinance rezoning property located at 1235 East German Lane from R-1 and O-2 to MF-1. **Vote 7-0**
- O-18-110 Ordinance rezoning property located at 1295 East German Lane from R-1 and O-2 to MF-1. **Vote 7-0**
