**Ordinances Passed:**

- O-16-115 Ordinance appropriating funds in the amount of \$350,000 for the moving and restoration of Springfield/Des Arc Bridge. **Vote 7-0**
- O-16-116 Ordinance appropriating funds in the amount of \$15,000 for the travel of Conway District Court Department DWI team and acceptance of reimbursement from the AR State Police Highway Safety Program Grant. **Vote 7-0**

- R-16-41 Resolution requesting the Faulkner County Tax Collector to place certified lien on property located at 2116 Prince Street as a result of incurred expenses by the City. **Vote 7-0**

- R-16-49 Resolution of a levy of **four-tenths (.4) mill** on the dollar be made upon the assessed valuation of all taxable real estate and personal property tax for raising special revenue for the Pension and Relief Fund for a **Policeman's Pension and Relief Fund**. **Vote 7-0**
- R-16-50 Resolution of a levy of **four-tenths (.4) mill** on the dollar be made upon the assessed valuation of all taxable real estate and personal property tax for raising special revenue for the Pension and Relief Fund for a **Fireman's Pension and Relief Fund**. **Vote 7-0**
- R-16-51 Resolution of a levy of **four-tenths (.4) mill** on the dollar be made upon the assessed valuation of all taxable real estate and personal property tax for raising special revenue for the Pension and Relief Fund for paid **Non-uniformed employees**. **Vote 7-0**
