Ordinances Passed:

- O-15-117 Ordinance to close certain right of ways and easements located in approximately 15.46 acres of property located at the former site of the Lewis Livestock auction in conjunction with the Lewis Crossing Development. **Vote 6-0**
- O-15-118 Ordinance to close the unbuilt right of way along Bob Courtway Drive. **Vote 6-0**
- O-15-119 Ordinance to authorize the issuance and sale of not to exceed \$610,000 of taxable electric franchise fee revenue refunding bonds (Hewlett-Packard Company Project), Series 2015. **Vote 6-0**
